It was a day of celebration for Brittney Ferguson and her family as Brittney marked her 20th birthday Tuesday, Jan. 27.

Life as she once knew it changed drastically for Ferguson when she was involved in an auto accident Sept. 25 in Laramie, Wyo., where she was a student at the University of Wyoming.

Now a rehab patient at Craig Hospital in Englewood, Brittney's progress is steady, but very slow.

Her mother Connie reported Monday that this past week was better than the previous one, as Brittney recovered from the dehydration that was making her very sick.

In fact, she was well enough to go out on her first outing to the Stock Show and Rodeo Wednesday, Jan. 21.

"She did very well, and never cried all day. She seemed to enjoy it," said Connie.

One day last week, Brittney figured out how to disconnect her feeding tube and just eat it. Her mother joked that she couldn't imagine it tasted good, but Brittney seemed to think she was funny doing it.

Connie added Brittney was pretty tight and toned over the weekend, so she cried a lot. Monday, she did well with therapy and scooted herself around in a wheelchair, propelling herself with her left foot.

"We still don't have a way to communicate with her," said Connie, explaining their way of communicating with their daughter is that she screams, and they have to guess what it is that's bugging her. "It does get hard to take some days," admitted Connie.

Initially hospitalized at Medical Center of the Rockies in Loveland, Brittney suffered a fractured skull, multiple face fractures, broken ribs, a blown eye socket, fractured right ankle and foot wounds, among other traumas.

On Oct. 14, Brittney was moved to Kindred Hospital in Denver, and a month later she relocated to Craig Hospital in Englewood.

Her parents, Rance and Connie, as well as sister Amanda, a junior at Holyoke High School (HHS), have remained with her for the four months since her accident.
